**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Since approximately 2017, housing prices began to grow faster than area median incomes (AMI). In 2019, 45% of renters were cost burdened, which is defined as spending more than 30% of household income on housing costs. In July 2023, NCHFA published a study showing the approximately 72% of low-income renters, those with incomes at or below 80% of AMI, were cost burdened state-wide and over 50% of low-income renters in Carteret County were cost burdened. The impacts of the Covid Pandemic and loss of affordable units due to natural disasters requires changes in the way we approach addressing housing needs and increases are need for service partners to ensure our families can successfully find safe, healthy housing. Affordable housing options are needed in a variety of sizes to meet the needs of families both with and without children. CCA will increase community partnerships to provide support for marginalized populations, those experiencing homelessness and those fleeing domestic violence to improve housing outcomes. CCA must develop tools and relationships to incentivize greater participation among private landlords in the county.</p> |

| <b>B.3</b> | <p><b>Progress Report.</b> Provide a description of the PHA's progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>There has been difficulty meeting the goals of the 5-year plan, that was written in 2020. A revised 5-year plan is due for submission in 2024. Increases in rent costs due to the pandemic's (Covid) impact housing choices as well as lack of affordable housing development, on-going challenges due to loss of older and affordable units from Hurricanes Matthew and Florence have made it difficult to increase leasing and FSS participation, though we will continue to work on those goals. The increase in families experiencing homelessness and those at risk of homelessness and the critical need for affordable housing in every community in our region has increased our challenges.</p> <p>However, federally funded programs to address the impact of the pandemic and fund responses to homelessness may provide CCA an opportunity to partner with community members and stakeholders in a way that we have not done previously, which, though not included in the last 5-year plan, will be included in our revised 5-year plan and will increase CCA's positive impact in our community.</p> <p>Efforts continue to improve participation in the Family Self-sufficiency Program (FSS). Enrollment has dropped and creativity is needed to incentivize families to attend meetings and enroll. CCA also needs to conduct listening sessions with families to collect information about their understanding of how FSS works, improve program marketing, and ensure we emphasize services and opportunities that will benefit our families based on their stated needs and goals.</p>   |

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
